Consent and Release

I, the parent/legal guardian of the participant named above with full authority to act on the participant's behalf, hereby give consent for participation in any and all Michigan Youth Football and Cheer Conference (hereinafter referred to as MYFCC) and/or Farmington Rockets Junior Football, Inc. (hereinafter referred to as Farmington Rockets) practices, games and activities. I understand that there are risks of physical injury with the sport of football/cheerleading and I, on my own behalf and on behalf of the participant named above and any other parent/legal guardian of the participant, hereby waive, release, absolve, indemnify and agree to hold harmless MYFCC and/or Farmington Rockets and each of their officers, directors, coaches, assistant coaches, organizers, other participants, medical care professionals, and other representatives for any and all claims arising out of any injury to the above named participant. I further grant the Farmington Rockets the power to act in my absence and on my behalf in deciding to administer emergency medical treatment on the participant by any licensed medical care professional and/or at any licensed medical facility, as if I had made the decision myself.

Parent Participation Requirements and Deposit

I understand that parent participation is mandatory and at least one parent/guardian from each participant's family is required to volunteer at least twice for jobs PER EACH PARTICIPANT such as concession stand sales, concession stand clean up, apparel sales, chain gang, spotter, announcer, field clean up, scorekeeper, pictures/website album, 50/50 raffle and also for various committees to organize fundraising, parade, banquet, yearbook and homecoming IN ORDER FOR PARTICIPANT TO BE ELIGIBLE TO PLAY. I understand and agree that I will fulfill my comment. I will provide a deposit of \$100. I understand that it will only be returned to me in full if I fulfill my agreement.

Registration and Fundraising Fees

I understand that the fees paid for registration and fundraising are not refundable; and if my check is returned due to insufficient funds, I am responsible for paying the bank fine.

Physical Required

I understand that a current physical, **signed and stamped** by a physician, must be submitted before the first practice or my child will not be allowed to participate.

Certificate of Birth

I understand that a copy of my child(ren)'s Certificate of Birth will be submitted before the first practice or my child will not be allowed to participate.

Uniform and Equipment Security Deposit

I assume full responsibility for the football/cheerleading uniform and all equipment issued to my child, and I agree to not alter the uniform or equipment in any way. I agree to return all items on the assigned turn-in date, clean and in the same condition received except for any wear and tear caused by normal usage during the season. I agree to pay a deposit of \$100 for Cheer and \$100 for Football for each child on equipment/uniform day. I understand that if I comply with said terms, I will receive my deposit back in full.

Football Shoes

Football shoes must be made of molded rubber cleats with a leather, canvas, or synthetic material upper. Cleats must be no longer than 1/2 inch in length, with not less than eight cleats per shoe. No screw-in, hard, or metal cleats allowed. If the player's shoes do not meet these requirements, the player will not be permitted to play.
